2.3 Other hazards:	
Inhalation:	can cause severe respiratory irritation and systemic toxicity because the substance can release hydrogen cyanide, posing a serious risk even at low exposure levels.
Ingestion:	small amounts can be life-threatening due to rapid release of hydrogen cyanide, leading to severe systemic toxicity.
Skin Contact:	can cause irritation and allow toxic absorption, with potential systemic effects due to cyanide release.
Eye contact:	can cause severe irritation and eye damage, with the risk of systemic toxicity if absorbed through the tissues.
Chronic Exposure:	may lead to cumulative toxic effects, including nervous system and organ damage, due to ongoing low-level cyanide release.
Aggravation of pre-existing conditions:	may worsen existing respiratory, cardiovascular, or neurological conditions due to its toxic and irritant effects.
