Skin Contact:	can cause severe burns, redness, pain, and blistering due to its corrosive nature.

4.1 Description of first aid measures	
General information:	
After inhalation:	If breathed in, move person into fresh air. If not breathing, give artificial respiration. Consult a physician.

6.1 Personal precautions, protective equipment and emergency procedures:	Use personal protective equipment. Avoid breathing vapors, mist or gas. Ensure adequate ventilation. Remove all sources of ignition. Evacuate personnel to safe areas. Beware of vapours accumulating to form explosive concentrations. Avoid dust accumulation. Seek medical attention.

6.3 Methods and material for containment and cleaning up:	Take up spill into absorbent material, e.g.: sand, earth, vermiculite, powdered limestone. Scoop absorbed substance into closing containers. Spill must not return in its original container. Wash clothing and equipment after handling.
