Inhalation:	can irritate the respiratory tract, cause coughing, shortness of breath, and with prolonged exposure, may affect bones and kidneys.
Ingestion:	can cause nausea, vomiting, abdominal pain, diarrhea, and in severe cases, it may lead to fluoride poisoning affecting the bones and kidneys.
Skin Contact:	can cause irritation, redness, and possible allergic reactions with prolonged or repeated exposure.
Eye contact:	can cause irritation, redness, tearing, and discomfort.
Chronic Exposure:	may lead to skeletal fluorosis, kidney damage, and possible nervous system effects over time.
Aggravation of pre-existing conditions:	may worsen pre-existing respiratory, kidney, or bone disorders.

General information:

4.2 Most important symptoms and effects, both acute and delayed:	Acute exposure can cause irritation of the eyes, skin, and respiratory tract, nausea, and vomiting, while delayed or chronic exposure may lead to skeletal fluorosis, kidney damage, and neurological effects.
