<b>Inhalation:</b>	Breathing in dust or fumes can irritate the nose, throat, and lungs due to the release of ammonia gas.
<b>Ingestion:</b>	may cause irritation of the mouth, throat, and stomach, leading to nausea or discomfort.
<b>Skin Contact:</b>	may cause mild skin irritation, especially with prolonged or repeated exposure.
<b>Eye contact:</b>	dust or solution can cause eye irritation, redness, and watering.
<b>Chronic Exposure:</b>	Repeated or long-term exposure to ammonium bicarbonate may cause ongoing irritation of the eyes, skin, or respiratory system.
<b>Aggravation of pre-existing conditions:</b>	may worsen existing respiratory conditions (such as asthma) or sensitive skin and eye conditions due to its irritant effects.
