2.3 Other hazards:	
Inhalation:	can irritate the respiratory tract, cause coughing, chest pain, shortness of breath, and severe exposure may lead to systemic fluoride poisoning.
Ingestion:	can cause severe burns to the mouth, throat, and stomach, nausea, vomiting, abdominal pain, and potentially life-threatening fluoride poisoning affecting the heart and bones.
Skin Contact:	can cause severe chemical burns, redness, pain, blistering, and deep tissue damage due to fluoride ion penetration.
Eye contact:	can cause severe irritation, pain, redness, corneal burns, and permanent eye damage or vision loss.
Chronic Exposure:	can lead to fluoride accumulation in the body, causing weakened bones (fluorosis), joint pain, dental issues, and potential kidney or liver damage.
Aggravation of pre-existing conditions:	can aggravate pre-existing respiratory conditions, skin disorders, and kidney or bone diseases, making symptoms more severe.

General information:	
After inhalation:	If breathed in, move person into fresh air. If not breathing, give artificial respiration. Consult a physician.

5.1 Extinguishing media:	Carbon dioxide. Water spray. Alcohol-resistant foam.
