2.3 Other hazards:	
Inhalation:	dust or fumes can irritate the respiratory tract, causing coughing, shortness of breath, and possible lung inflammation with prolonged exposure.
Ingestion:	can cause nausea, vomiting, abdominal pain, and diarrhea, and in large amounts may affect kidney and liver function.
Skin Contact:	may cause mild irritation, redness, or itching, especially after prolonged or repeated exposure.
Eye contact:	can cause irritation, redness, and watering, and may result in discomfort or temporary eye injury.

General information:
