2.3 Other hazards:	
Inhalation:	dust or fumes may irritate the respiratory tract and can lead to toxic effects such as muscle weakness, breathing difficulty, or nervous system disturbances due to soluble barium absorption.
Ingestion:	Ingestion is highly toxic and may cause gastrointestinal irritation, muscle weakness or paralysis, low blood potassium levels, and serious heart rhythm disturbances.
Skin Contact:	may cause irritation or redness, and prolonged or repeated exposure can allow absorption of toxic barium ions through damaged skin.
Eye contact:	may cause irritation, redness, pain, and possible injury due to the compound's irritating and toxic properties.
Chronic Exposure:	may result in ongoing muscle weakness, nervous system effects, cardiovascular disturbances, and other systemic toxicity due to prolonged barium accumulation.
Aggravation of pre-existing conditions:	may aggravate pre-existing conditions involving the heart, nervous system, muscles, respiratory system, or electrolyte imbalances.
