2.3 Other hazards:	
Inhalation:	can irritate the respiratory tract and, in large amounts, may cause coughing, shortness of breath, and systemic barium poisoning.
Ingestion:	can cause nausea, vomiting, abdominal pain, diarrhea, muscle weakness, and in severe cases, irregular heartbeat or potentially life-threatening barium poisoning.
Skin Contact:	can cause mild irritation, redness, or itching, but it is generally less hazardous than ingestion or inhalation.
Eye contact:	can cause irritation, redness, and watering of the eyes.
Chronic Exposure:	may lead to persistent muscle weakness, high blood pressure, kidney damage, and other long-term health effects due to gradual barium accumulation in the body.
Aggravation of pre-existing conditions:	can aggravate pre-existing respiratory, cardiovascular, or kidney conditions, potentially worsening symptoms like breathing difficulties, high blood pressure, or impaired kidney function.

General information:
