2.3 Other hazards:	
Inhalation:	dust or fumes can irritate the respiratory tract, cause coughing, shortness of breath, and, in high exposures, affect the heart or nervous system.
Ingestion:	can cause nausea, vomiting, diarrhea, abdominal pain, muscle weakness, and in severe cases, it can affect the heart and nervous system.
Skin Contact:	can cause irritation, redness, and itching, and prolonged exposure may lead to more severe irritation or chemical burns.
Eye contact:	can cause irritation, redness, watering, and pain, and may result in temporary damage if not rinsed promptly.
Chronic Exposure:	can lead to barium accumulation in the body, causing muscle weakness, kidney damage, high blood pressure, and potential effects on the nervous system and bones.
Aggravation of pre-existing conditions:	may worsen pre-existing respiratory, kidney, or heart conditions and can increase sensitivity in individuals with weakened nervous or muscular systems.
