Inhalation:	can cause respiratory irritation, coughing, and long-term lung issues if exposure is prolonged.
Ingestion:	generally non-toxic due to its insolubility, but large amounts of fine powder may cause digestive discomfort or constipation.
Skin Contact:	generally non-irritating and low-risk, but prolonged or repeated exposure to dust may cause mild dryness or irritation.
Eye contact:	may cause mild irritation or redness, especially if the powder gets into the eyes, but it is generally not harmful.
