2.3 Other hazards:	
Inhalation:	can cause severe respiratory irritation, coughing, shortness of breath, lung inflammation, and long-term exposure may lead to chronic lung disease or kidney damage.
Ingestion:	can cause severe gastrointestinal irritation, vomiting, diarrhea, abdominal pain, and may lead to kidney and liver damage or even be fatal in high doses.

Skin Contact:	can cause irritation, redness, and possible chemical burns, and prolonged exposure may lead to absorption into the body, causing systemic toxicity.
