2.3 Other hazards:	
Inhalation:	can cause respiratory irritation, coughing, sneezing, and, with prolonged exposure, possible lung tissue irritation or chronic respiratory issues.
Ingestion:	can cause stomach upset, nausea, vomiting, constipation, or, in severe cases, hypercalcemia (high blood calcium levels) and kidney problems.
Skin Contact:	may cause mild irritation, dryness, or redness, but it is generally considered low in toxicity.
Eye contact:	can cause irritation, redness, tearing, and discomfort, but it is generally not corrosive.
Chronic Exposure:	mainly through inhalation of dust over long periods, can lead to persistent respiratory irritation, coughing, and in rare cases, lung tissue changes, but it is generally considered low-toxicity with no severe long-term effects.
Aggravation of pre-existing conditions:	may aggravate pre-existing respiratory conditions such as asthma or chronic bronchitis, causing increased coughing, shortness of breath, or irritation.
