Inhalation:	Other hazards include respiratory tract irritation and potential lung damage from prolonged or repeated exposure to calcium fluoride dust.
Ingestion:	May cause gastrointestinal irritation, nausea, vomiting, and abdominal discomfort if swallowed in significant amounts.
Skin Contact:	May cause mild irritation, redness, or dryness with prolonged or repeated contact.
Eye contact:	May cause irritation, redness, tearing, and discomfort, especially if dust enters the eyes.
Chronic Exposure:	Prolonged or repeated exposure may lead to fluoride accumulation in the body, potentially causing skeletal or dental fluorosis over time.
Aggravation of pre-existing conditions:	May worsen existing respiratory, skin, eye, or bone conditions, particularly in individuals sensitive to fluoride compounds.
