<b>2.3 Other hazards:</b>	
<b>Inhalation:</b>	can cause irritation of the respiratory tract, coughing, shortness of breath, and possible pulmonary edema in severe exposure.
<b>Ingestion:</b>	can cause nausea, vomiting, abdominal pain, diarrhea, and in large amounts, iodine toxicity affecting the thyroid and potentially leading to systemic effects.
<b>Skin Contact:</b>	can cause irritation, redness, and possible dermatitis, especially with prolonged or repeated exposure.
<b>Eye contact:</b>	can cause severe irritation, redness, pain, and possible temporary damage to the cornea.
<b>Chronic Exposure:</b>	can lead to thyroid dysfunction, skin sensitization, respiratory irritation, and cumulative effects from prolonged ingestion or inhalation of iodine-containing compounds.
<b>Aggravation of pre-existing conditions:</b>	may aggravate pre-existing respiratory conditions (like asthma), thyroid disorders, skin sensitivities, and eye problems.
