Eye contact:	may cause irritation, redness, tearing, and discomfort.
Chronic Exposure:	may lead to persistent thyroid dysfunction and related metabolic effects due to long-term perchlorate absorption.
Aggravation of pre-existing conditions:	Aggravation of pre-existing conditions may occur, particularly in individuals with thyroid disorders, respiratory sensitivities, or skin and eye irritation conditions.
