<b>Inhalation:</b>	can cause respiratory tract irritation, coughing, shortness of breath, and in high concentrations, central nervous system effects like dizziness or nausea.
<b>Ingestion:</b>	may cause gastrointestinal irritation, nausea, vomiting, abdominal pain, and potentially more severe toxic effects if a significant amount is swallowed.
<b>Skin Contact:</b>	can cause irritation, redness, itching, and possible chemical burns with prolonged or repeated exposure.
<b>Eye contact:</b>	can cause severe irritation, redness, pain, and potential damage to the cornea.
<b>Chronic Exposure:</b>	may lead to skin sensitization, dermatitis, respiratory irritation, and potential long-term effects on the liver or nervous system with repeated or prolonged contact.
