2.3 Other hazards:	
Inhalation:	can cause respiratory irritation, coughing, shortness of breath, and long-term exposure may lead to asthma or lung sensitization.
Ingestion:	can cause nausea, vomiting, abdominal pain, diarrhea, and may lead to systemic cobalt poisoning affecting the heart and thyroid.
Skin Contact:	can cause irritation, redness, itching, and in some cases allergic skin reactions or dermatitis.
Eye contact:	can cause severe irritation, redness, pain, and potential damage to the cornea if not rinsed promptly.
Chronic Exposure:	can lead to skin sensitization, respiratory issues such as asthma

	or lung fibrosis, heart problems, thyroid dysfunction, and potential carcinogenic effects with prolonged contact or inhalation.
Aggravation of pre-existing conditions:	can aggravate pre-existing respiratory conditions (like asthma or bronchitis), skin disorders (such as eczema), and cardiovascular or thyroid problems.

6.1 Personal precautions, protective equipment and emergency procedures:	Use personal protective equipment. Avoid breathing vapors, mist or gas. Ensure adequate ventilation. Remove all sources of ignition. Evacuate personnel to safe areas. Beware of vapours accumulating to form explosive concentrations. Avoid dust accumulation. Seek medical attention.

6.3 Methods and material for containment and cleaning up:	Take up spill into absorbent material, e.g. sand, earth, vermiculite, powdered limestone. Scoop absorbed substance into closing containers.
