2.3 Other hazards:	
Inhalation:	can irritate the respiratory tract, cause coughing, shortness of breath, and may lead to metal fume fever with prolonged or high exposure.
Ingestion:	can cause nausea, vomiting, abdominal pain, diarrhea, and in severe cases, liver or kidney damage due to copper toxicity.
Skin Contact:	may cause irritation, redness, and itching, and prolonged or repeated exposure can lead to dermatitis.
Eye contact:	can cause irritation, redness, pain, and watering, and may damage the cornea if not rinsed promptly.
Chronic Exposure:	can lead to liver and kidney damage, respiratory issues, skin sensitization, and accumulation of copper in the body causing long-term toxicity.
Aggravation of pre-existing conditions:	may aggravate pre-existing respiratory conditions (like asthma or bronchitis) and skin disorders, increasing irritation or sensitivity.
