Inhalation:	dust or powder can irritate the respiratory tract, causing coughing, shortness of breath, or throat irritation.
Ingestion:	Ingestion in excessive amounts can cause nausea, vomiting, abdominal pain, diarrhea, and in severe cases, liver or kidney damage and systemic toxicity.
Skin Contact:	may cause mild irritation, redness, or itching, especially with prolonged or repeated exposure.
Eye contact:	can cause irritation, redness, and watering, and may result in discomfort or mild damage if not promptly rinsed.
Chronic Exposure:	usually through prolonged ingestion or repeated contact, can lead to copper accumulation in the liver and kidneys, resulting in liver damage, kidney dysfunction,

	anemia, neurological symptoms, and gastrointestinal disturbances.
Aggravation of pre-existing conditions:	may aggravate pre-existing liver or kidney disorders, gastrointestinal conditions, or Wilson's disease, a genetic disorder that causes copper accumulation in the body.
