2.3 Other hazards:	
Inhalation:	can irritate the respiratory tract and, at high concentrations, may cause dizziness, headache, nausea, and central nervous system depression.
Ingestion:	can cause severe poisoning, leading to nausea, vomiting, abdominal pain, kidney failure, central nervous system depression, and potentially death.
Skin Contact:	can cause irritation, redness, and, with prolonged or repeated exposure, may lead to dermatitis or absorption through the skin, contributing to systemic toxicity.
Eye contact:	can cause irritation, redness, pain, and tearing, and may lead to more serious eye damage with prolonged exposure.
