4.2 Most important symptoms and effects, both acute and delayed:	Acute exposure to ethyl bromide can cause dizziness, headache, nausea, respiratory irritation, and central nervous system depression, while delayed or chronic effects may include neurological damage, liver and kidney impairment, and persistent tremors or memory loss.

5.1 Extinguishing media:	Carbon dioxide dry powder, Alcohol-resistant foam.
5.2 Special hazards arising from the substance or mixture:	Carbon oxides, hydrogen bromid
5.3 Advice for firefighters:	Wear fully protective suit, safety glasses and respiratory device. Cool tanks/drums with water spray/remove them into safety.
