2.3 Other hazards:	
Inhalation:	can cause respiratory irritation, dizziness, headache, nausea, and in severe cases, central nervous system depression, liver and kidney damage, or long-term carcinogenic effects.
Ingestion:	can lead to nausea, vomiting, abdominal pain, diarrhea, dizziness, liver and kidney damage, and may be fatal in high doses.

General information:

	include liver and kidney damage, neurological disorders, reproductive toxicity, and increased cancer risk.

6.1 Personal precautions, protective equipment and emergency procedures:	Use personal protective equipment. Avoid breathing vapors, mist or gas. Ensure adequate ventilation. 6.3 Methods and material for containment and cleaning up:	Take up spill into absorbent material, e.g.: sand, earth, vermiculite, powdered limestone. Scoop absorbed substance into closing containers. Spill must not return in its original container. Clean contaminated surfaces with an excess of water. Wash clothing and equipment after handling.
