2.3 Other hazards:	
Inhalation:	can cause severe irritation of the respiratory tract, coughing, shortness of breath, and in high concentrations, pulmonary edema.
Ingestion:	can cause severe burns to the mouth, throat, and stomach, nausea, vomiting, abdominal pain, and potentially life-threatening systemic toxicity.
Skin Contact:	can cause severe chemical burns, redness, pain, and tissue damage, and prolonged exposure may lead to deep ulceration.

4.1 Description of first aid measures	
General information:	
After inhalation:	If breathed in, move person into fresh air. If not breathing, give artificial respiration. Consult a physician.
After skin contact:	First treatment with calcium gluconate paste. Immediately Remove contaminated clothing. Wash with soap and water. Consult a physician.
After eye contact:	Immediately flush eyes with plenty of water for at least 15 minutes. Immediately call in ophthalmologist. consult a physician.
After swallowing:	Rinse mouth with water. Immediately after ingestion. Never give anything by mouth to an unconscious person. Do not induce vomiting. Consult a physician.
4.2 Most important symptoms and effects, both acute and delayed:	The most important symptoms and effects include immediate severe burns, eye and skin irritation, respiratory distress, and gastrointestinal pain, with delayed effects potentially causing tissue damage, systemic fluoride toxicity, and long-term organ or bone damage.
4.3 Indication of any immediate medical attention and special treatment needed:	Treat symptomatically.

5.1 Extinguishing media:	Water, Carbon dioxide dry powder, Alcohol-resistant foam.
5.2 Special hazards arising from the substance or mixture:	Boron oxides, hydrogen fluoride.
5.3 Advice for firefighters:	Wear fully protective suit, safety glasses and respiratory device. Cool tanks/drums with water spray/remove them into safety.
