2.3 Other hazards:	
Inhalation:	dust may cause mild respiratory irritation, coughing, or sneezing, but it is generally considered low toxicity.

Skin Contact:	generally non-irritating and safe, though prolonged exposure to the powder may cause mild dryness or mechanical irritation.
