2.3 Other hazards:	
Inhalation:	can cause headache, dizziness, nausea, respiratory irritation, and in high concentrations, central nervous system depression or unconsciousness.
Ingestion:	can cause abdominal pain, nausea, vomiting, dizziness, drowsiness, low blood pressure, respiratory depression, and can be potentially fatal in large amounts.
Skin Contact:	can cause dryness, irritation, redness, and cracking with prolonged or repeated exposure.
Eye contact:	can cause severe irritation, redness, tearing, burning sensation, and potential temporary damage to the cornea.
Chronic Exposure:	can lead to skin dryness and dermatitis, respiratory irritation, headaches, dizziness, and potential effects on the liver and kidneys with long-term inhalation or ingestion.

	liver or kidney strain, and prolonged respiratory issues.
4.3 Indication of any immediate medical attention and special treatment needed:	Treat symptomatically.

5.1 Extinguishing media:	Water, Carbon dioxide dry powder, Alcohol-resistant foam.
5.2 Special hazards arising from the substance or mixture:	Carbon oxides.
5.3 Advice for firefighters:	Wear fully protective suit, safety glasses and respiratory device. Cool tanks/drums with water spray/remove them into safety.

SECTION 6: Accidental release measures

6.1 Personal precautions, protective equipment and emergency procedures:	Use personal protective equipment. Avoid breathing vapors, mist or gas. Ensure adequate ventilation.
