Skin Contact:	can cause skin irritation and allows lead to be absorbed through the skin, potentially leading to systemic lead poisoning with repeated or prolonged exposure.
Eye contact:	can cause eye irritation, redness, and pain, with potential damage if not promptly and thoroughly rinsed.
Chronic Exposure:	Long-term or repeated exposure can result in cumulative lead poisoning, causing anemia, neurological impairment, kidney damage, and reproductive toxicity.

Aggravation of pre-existing conditions:	may worsen existing kidney disease, neurological disorders, anemia, and reproductive health conditions.

4.1 Description of first aid measures	
General information:	
After inhalation:	If breathed in, move person into fresh air. If not breathing, give artificial respiration. Consult a physician.
