2.3 Other hazards:	
Inhalation:	dust or aerosols can irritate the respiratory tract and cause systemic lead poisoning, affecting the nervous system, kidneys, and blood over time.
Ingestion:	can cause severe gastrointestinal pain, vomiting, diarrhea, and long-term effects such as neurological damage, kidney injury, and anemia.
Skin Contact:	can cause skin irritation and may be absorbed through the skin, potentially leading to systemic lead poisoning with repeated or prolonged exposure.

Eye contact:	can cause eye irritation, redness, and pain, and prolonged exposure may result in more serious eye damage if not promptly rinsed.
Chronic Exposure:	can lead to cumulative lead poisoning, causing neurological impairment, anemia, kidney damage, and reproductive toxicity.
Aggravation of pre-existing conditions:	may worsen existing kidney disease, neurological disorders, anemia, and reproductive health problems.

4.1 Description of first aid measures	
General information:	
After inhalation:	If breathed in, move person into fresh air. If not breathing, give artificial respiration. Consult a physician.

4.2 Most important symptoms and effects, both acute and delayed:	Acute exposure can cause gastrointestinal irritation, nausea, and vomiting, while delayed effects include cumulative lead poisoning, resulting in neurological damage, anemia, kidney dysfunction, and reproductive toxicity.
4.3 Indication of any immediate medical attention and special treatment needed:	Treat symptomatically.

5.1 Extinguishing media:	Carbon dioxide, dry chemical, Alcohol-resistant foam.
