Eye contact:	can cause severe irritation, redness, pain, and potential damage to the cornea, with a risk of lead absorption through the mucous membranes.
Chronic Exposure:	can lead to cumulative lead poisoning, causing neurological deficits, kidney damage, anemia, reproductive toxicity, and developmental effects in children.
Aggravation of pre-existing conditions:	can aggravate pre-existing kidney, liver, neurological, and cardiovascular conditions, and may worsen respiratory or skin disorders.
