2.3 Other hazards:	
Inhalation:	dust can irritate the respiratory tract, causing coughing, shortness of breath, and throat discomfort.
Ingestion:	may cause nausea, vomiting, abdominal pain, diarrhea, and in high doses, lithium toxicity affecting the nervous system and kidneys.
Skin Contact:	can cause irritation, redness, and, in sensitive individuals, possible allergic reactions.
Eye contact:	can cause irritation, redness, watering, and a burning sensation.
Chronic Exposure:	may lead to cumulative lithium toxicity, potentially affecting the kidneys, thyroid, and nervous system, and causing symptoms like tremors, fatigue, and cognitive disturbances.
Aggravation of pre-existing conditions:	may aggravate pre-existing kidney, heart, or thyroid conditions, as well as neurological disorders, due to its potential effects on electrolyte balance and nervous system function.

General information:
