Inhalation:	dust or fumes can irritate the respiratory tract, causing coughing, shortness of breath, and, in severe cases, lung inflammation.
Ingestion:	can cause nausea, vomiting, abdominal pain, diarrhea, and in large amounts, may lead to lithium poisoning, affecting the nervous system and kidneys.
Skin Contact:	can cause irritation, redness, and dryness, and prolonged or repeated exposure may lead to dermatitis.
Eye contact:	can cause irritation, redness, pain, and watering, and may result in temporary damage to the cornea if not promptly rinsed.
Chronic Exposure:	can lead to prolonged lithium accumulation in the body, potentially causing kidney damage, neurological effects such as tremors or confusion, and thyroid dysfunction.
Aggravation of pre-existing conditions:	may aggravate pre-existing kidney, heart, or thyroid conditions and can worsen respiratory or skin disorders.
