2.3 Other hazards:	
Inhalation:	dust or fumes can irritate the respiratory tract, cause coughing, shortness of breath, and, in high concentrations, may lead to pulmonary edema.
Ingestion:	can cause nausea, vomiting, abdominal pain, diarrhea, and in severe cases, fluoride poisoning affecting the heart and nervous system.
Skin Contact:	can cause irritation, redness, and, with prolonged exposure, possible burns or dermatitis due to its corrosive nature.
Eye contact:	can cause severe irritation, redness, pain, and possible damage to the cornea.
Chronic Exposure:	can lead to skeletal fluorosis, dental fluorosis, kidney damage, and long-term effects on bones and teeth.
Aggravation of pre-existing conditions:	may aggravate pre-existing respiratory conditions (like asthma), skin disorders, or kidney and bone-related health issues.

General information:	
After inhalation:	If breathed in, move person into fresh air. If not breathing, give artificial respiration. Consult a physician.
