Inhalation:	can cause respiratory tract irritation, coughing, and shortness of breath, and prolonged exposure may lead to lung damage.
Ingestion:	can cause nausea, vomiting, diarrhea, abdominal pain, and at higher doses, lithium toxicity affecting the nervous system, kidneys, and heart.
Skin Contact:	May cause mild irritation, redness, or dryness, and prolonged or repeated exposure can lead to dermatitis.
Eye contact:	Can cause irritation, redness, and watering; direct contact may result in pain or temporary eye damage.
Chronic Exposure:	Prolonged or repeated exposure can lead to kidney damage, thyroid dysfunction, tremors, neurological effects, and other symptoms of lithium accumulation (toxicity).
Aggravation of pre-existing conditions:	can worsen kidney disease, thyroid disorders, cardiovascular problems, and neurological conditions, and may exacerbate dehydration or electrolyte imbalances.
