Skin Contact:	can cause irritation, redness, and possible chemical burns with prolonged or repeated exposure.
Eye contact:	can cause severe irritation, redness, pain, and potential damage to the cornea.
Chronic Exposure:	may lead to persistent respiratory issues, skin sensitization, and long-term irritation of the eyes and mucous membranes.
Aggravation of pre-existing conditions:	may aggravate pre-existing respiratory conditions (like asthma or bronchitis), skin disorders, or eye problems.

General information:	

After inhalation:	If breathed in, move person into fresh air. If not breathing, give artificial respiration. Consult a physician.
