Skin Contact:	may cause mild irritation, redness, or dryness, but it is generally considered low-toxicity through skin exposure.
Eye contact:	may cause irritation, redness, and watering, and direct exposure to dust can lead to discomfort or mild corneal irritation.
Chronic Exposure:	may lead to respiratory issues, kidney or liver effects, and possible accumulation of molybdenum in the body, though it is generally considered low-toxicity with proper handling.
