Inhalation:	dust or mist may irritate the respiratory tract, causing coughing, shortness of breath, or throat irritation.

4.1 Description of first aid measures	
General information:	
After inhalation:	If breathed in, move person into fresh air. If not breathing, give artificial respiration. Consult a physician.

4.2 Most important symptoms and effects, both acute and delayed:	Acute exposure can cause irritation of the eyes, skin, and respiratory tract, as well as nausea and gastrointestinal upset if ingested, while delayed or chronic exposure may lead to lithium accumulation, kidney or neurological effects, and worsening of pre-existing conditions.
