Ingestion:	May cause gastrointestinal irritation, nausea, vomiting, and potential systemic effects from perchlorate interfering with thyroid function if swallowed in significant amounts.
Skin Contact:	Can cause irritation, redness, or burns, especially with prolonged or repeated exposure, due to its strong oxidizing nature.
Eye contact:	Can cause severe irritation, redness, pain, and potential damage to the eyes upon direct contact.
Chronic Exposure:	Prolonged or repeated exposure may affect thyroid function, cause skin or respiratory irritation, and potentially lead to systemic effects from accumulation of perchlorate in the body.
Aggravation of pre-existing conditions:	may worsen respiratory disorders, thyroid problems, or skin conditions in individuals with pre-existing sensitivities.
