2.3 Other hazards:	
Inhalation:	can cause respiratory irritation, coughing, shortness of breath, and possible lung inflammation.
Ingestion:	can cause nausea, vomiting, abdominal pain, diarrhea, and in severe cases, lithium toxicity affecting the nervous system and kidneys.
Skin Contact:	can cause mild irritation, redness, or dryness, and prolonged exposure may lead to dermatitis.
Eye contact:	can cause irritation, redness, watering, and possible discomfort or corneal injury with prolonged exposure.
Chronic Exposure:	can lead to kidney damage, nervous system effects (such as tremors or fatigue), and potential respiratory or skin sensitization over time.
Aggravation of pre-existing conditions:	may aggravate pre-existing respiratory conditions (like asthma), kidney disorders, and skin sensitivities.

General information:
