2.3 Other hazards:	
Inhalation:	can cause respiratory irritation, coughing, shortness of breath, and, with prolonged exposure, potential lung damage.
Ingestion:	can cause nausea, vomiting, abdominal pain, diarrhea, and in severe cases, systemic fluoride poisoning affecting the heart and kidneys.
Skin Contact:	can cause mild irritation, redness, or itching, and prolonged or repeated exposure may lead to dermatitis.
Eye contact:	can cause irritation, redness, tearing, and discomfort, and in severe cases, corneal damage may occur.
Chronic Exposure:	can lead to skeletal fluorosis, dental fluorosis, kidney damage, and respiratory issues from prolonged inhalation of dust or fumes.
Aggravation of pre-existing conditions:	may aggravate pre-existing respiratory conditions, skin disorders, or kidney problems, worsening symptoms in affected individuals.

4.1 Description of first aid measures	
General information:	
After inhalation:	If breathed in, move person into fresh air. If not breathing, give artificial respiration. Consult a physician.

4.2 Most important symptoms and effects, both acute and delayed:	The most important symptoms and effects include respiratory irritation, coughing, nausea, vomiting, abdominal pain, skin and eye irritation, and with prolonged or repeated exposure, skeletal and dental fluorosis, kidney damage, and potential lung effects.
