2.3 Other hazards:	
Inhalation:	dust or fumes can irritate the respiratory tract, causing coughing, shortness of breath, and throat discomfort.
Ingestion:	can cause nausea, vomiting, abdominal pain, diarrhea, and in severe cases, methemoglobinemia or other systemic toxicity.
Skin Contact:	can cause irritation, redness, and possible dermatitis, especially with prolonged or repeated exposure.
Eye contact:	can cause irritation, redness, pain, and possible temporary damage to the cornea.
Chronic Exposure:	may lead to prolonged skin or respiratory irritation, and repeated ingestion could affect kidney function or cause other systemic effects due to nitrate accumulation.
Aggravation of pre-existing conditions:	may aggravate pre-existing respiratory conditions (like asthma or bronchitis) and skin disorders, increasing irritation or sensitivity.

4.1 Description of first aid measures	
General information:	

After inhalation:	If breathed in, move person into fresh air. If not breathing, give artificial respiration. Consult a physician.
After skin contact:	Remove contaminated clothing immediately. Wash with plenty of water. Consult a physician.
After eye contact:	Immediately flush eyes with plenty of water for at least 15 minutes. consult a physician.
After swallowing:	Rinse mouth with water. Immediately after ingestion. If conscious, make victim drink two glasses at most immediately. Never give anything by mouth to an unconscious person. Do not induce vomiting. Consult a physician.
4.2 Most important symptoms and effects, both acute and delayed:	Acute exposure can cause respiratory, skin, and eye irritation, nausea, and vomiting, while delayed effects may include prolonged respiratory or skin irritation and systemic effects from nitrate accumulation.

5.1 Extinguishing media:	Water, Carbon dioxide dry chemical, Alcohol-resistant foam.
5.2 Special hazards arising from the substance or mixture:	Magnesium oxides, nitrogen oxides.
