2.3 Other hazards:	
Inhalation:	can irritate the respiratory tract, cause coughing, sneezing, and prolonged exposure may lead to lung inflammation or silicosis-like effects.
Ingestion:	generally considered low in toxicity but may cause mild gastrointestinal irritation, nausea, vomiting, or constipation if swallowed in large amounts.
Skin Contact:	may cause mild irritation or dryness, especially with prolonged or repeated exposure, but it is generally not highly toxic.
Eye contact:	can cause mechanical irritation, redness, tearing, and discomfort, but it is not chemically corrosive.
Chronic Exposure:	may lead to lung issues such as pulmonary fibrosis or silicosis-like respiratory problems, as well as prolonged skin or eye irritation with repeated contact.
Aggravation of pre-existing conditions:	can aggravate pre-existing respiratory conditions (like asthma or chronic bronchitis) and may worsen skin or eye sensitivities in individuals prone to irritation.

General information:	

After inhalation:	If breathed in, move person into fresh air. If not breathing, give artificial respiration. Consult a physician.
