2.3 Other hazards:	
Inhalation:	can irritate the respiratory tract, causing coughing, difficulty breathing, and potential lung damage with prolonged exposure.
Ingestion:	can cause severe gastrointestinal irritation, nausea, vomiting, abdominal pain, and toxic fluoride poisoning, which may affect the heart and kidneys.
Skin Contact:	can cause irritation, redness, and possible chemical burns, especially with prolonged or repeated exposure.
Eye contact:	can cause severe irritation, redness, pain, tearing, and potential chemical burns to the eyes.
Chronic Exposure:	can lead to fluoride accumulation in the body, causing skeletal fluorosis, dental fluorosis, kidney damage, and long-term respiratory or skin irritation.
Aggravation of pre-existing conditions:	can worsen pre-existing respiratory conditions (like asthma), kidney disorders, and skin sensitivities, and may exacerbate heart problems due to fluoride toxicity.

4.1 Description of first aid measures	
General information:	
After inhalation:	If breathed in, move person into fresh air. If not breathing, give artificial respiration. Consult a physician.

4.2 Most important symptoms and effects, both acute and delayed:	Acute and delayed exposure can cause respiratory irritation, coughing, nausea, vomiting, abdominal pain, chemical burns to skin and eyes, and long-term effects like skeletal and dental fluorosis, kidney damage, and chronic respiratory issues.
