2.3 Other hazards:	
Inhalation:	can cause respiratory irritation, coughing, shortness of breath, and with chronic exposure, may lead to neurological effects known as manganism.
Ingestion:	can cause nausea, vomiting, abdominal pain, diarrhea, and in severe or repeated cases, may affect the nervous system.
Skin Contact:	may cause mild irritation, redness, or itching, but it is generally not highly toxic through skin absorption.
Eye contact:	can cause irritation, redness, watering, and a stinging or burning sensation.
Chronic Exposure:	especially through inhalation, can lead to neurological symptoms such as tremors, memory loss, mood changes, and a condition called manganism, as well as potential respiratory and lung effects.
Aggravation of pre-existing conditions:	may aggravate pre-existing respiratory conditions (like asthma or chronic bronchitis) and neurological disorders, potentially worsening symptoms such as breathing difficulties, fatigue, or cognitive impairments.

General information:
