2.3 Other hazards:	
Inhalation:	dust can irritate the respiratory tract and, with prolonged or high exposure, may lead to neurological effects associated with manganese toxicity.
Ingestion:	may cause gastrointestinal irritation, including nausea, vomiting, and abdominal pain, and excessive exposure can contribute to systemic manganese toxicity.
Skin Contact:	may cause mild irritation, dryness, or staining, especially with prolonged or repeated exposure.
Eye contact:	dust may cause irritation, redness, tearing, and discomfort.
Chronic Exposure:	may lead to neurological effects such as tremors, coordination difficulties, and behavioral changes associated with manganism.
Aggravation of pre-existing conditions:	particularly via inhalation, may aggravate pre-existing respiratory conditions (like asthma or chronic bronchitis) and neurological disorders, potentially worsening symptoms such as breathing difficulties, fatigue, or cognitive impairments.

General information:
