2.3 Other hazards:	
Inhalation:	can cause respiratory irritation, coughing, shortness of breath, and with prolonged exposure, may affect the nervous system.
Ingestion:	can cause nausea, vomiting, abdominal pain, and in severe or repeated cases, may lead to neurological effects.
Skin Contact:	may cause mild irritation, redness, or dryness, but it is generally not highly toxic through skin exposure.
Eye contact:	can cause irritation, redness, and watering, and may lead to temporary discomfort if particles get into the eyes.
Chronic Exposure:	especially by inhalation, can lead to neurological effects such as tremors, difficulty walking, mood changes, and impaired memory, a condition known as manganism.
Aggravation of pre-existing conditions:	may aggravate pre-existing respiratory, neurological, or liver conditions, worsening symptoms such as breathing difficulties, tremors, or liver dysfunction.
