Inhalation:	can severely irritate and burn the respiratory tract, potentially causing coughing, shortness of breath, lung injury, and delayed pulmonary edema.
Ingestion:	can cause severe burns to the mouth, throat, esophagus, and stomach, along with nausea, vomiting, abdominal pain, and potentially life-threatening systemic toxicity.
Skin Contact:	can cause severe chemical burns, blistering, and deep tissue damage, and may be absorbed through the skin, leading to systemic toxicity.
Eye contact:	can cause severe eye irritation, chemical burns, corneal damage, and potentially permanent vision loss.
Chronic Exposure:	may lead to skin sensitization, dermatitis, respiratory irritation, and potential damage to internal organs from systemic absorption.
Aggravation of pre-existing conditions:	can worsen respiratory disorders (like asthma or bronchitis), skin conditions (such as eczema), and eye sensitivities, and may increase the severity of chemical burns or systemic toxicity in individuals with liver or kidney problems.
