



<p>Inhalation:</p>	<p>can cause severe respiratory irritation, dizziness, nausea, headache, and central nervous system depression, and prolonged exposure may lead to serious neurological or organ damage.</p>

Ingestion:	can cause severe gastrointestinal irritation, nausea, vomiting, abdominal pain, and may lead to systemic toxicity affecting the nervous system, liver, and kidneys.
Skin Contact:	can cause irritation, redness, and burning, and prolonged or repeated exposure may lead to absorption through the skin, causing systemic toxicity.
Eye contact:	can cause severe irritation, redness, pain, and potential temporary or permanent damage to the eyes.

4.1 Description of first aid measures	
General information:	
After inhalation:	If breathed in, move person into fresh air. If not breathing, give artificial respiration. Consult a physician.

4.2 Most important symptoms and effects, both acute and delayed:	Acute exposure can cause respiratory irritation, headache, dizziness, nausea, vomiting, and skin or eye irritation, while delayed effects may include neurological damage, organ toxicity, and increased cancer risk.
4.3 Indication of any immediate medical attention and special treatment needed:	Treat symptomatically.

6.3 Methods and material for containment and cleaning up:	Take up spill into absorbent material, e.g.: sand, earth, vermiculite, powdered limestone. Scoop absorbed substance into closing containers. Spill must not return in its original container. Clean contaminated surfaces with an excess of water. Wash clothing and equipment after handling.
