<b>Inhalation:</b>	can cause respiratory irritation, coughing, and shortness of breath, and high concentrations may lead to dizziness or headache.
<b>Ingestion:</b>	may cause nausea, vomiting, abdominal pain, and systemic effects such as flushing, dizziness, or headache.
<b>Skin Contact:</b>	can cause redness, burning, irritation, and, in high concentrations, a strong warming sensation or dermatitis.
