2.3 Other hazards:	
Inhalation:	vapors can irritate the respiratory tract and, at high concentrations, may cause headache, dizziness, nausea, or salicylate toxicity symptoms.
Ingestion:	can cause severe salicylate poisoning, leading to nausea, vomiting, metabolic acidosis, respiratory distress, seizures, or death.
Skin Contact:	may cause irritation, redness, or burns, and excessive absorption through the skin can lead to systemic salicylate toxicity.
Eye contact:	can cause severe irritation, redness, pain, and possible corneal injury.
Chronic Exposure:	may lead to cumulative salicylate toxicity, causing symptoms such as headaches, tinnitus, nausea, metabolic disturbances, and organ damage.
Aggravation of pre-existing conditions:	may aggravate pre-existing conditions such as asthma, aspirin/salicylate sensitivity, skin

General information:	
After inhalation:	If breathed in, move person into fresh air. If not breathing, give artificial respiration. Consult a physician.

4.2 Most important symptoms and effects, both acute and delayed:	The most important acute and delayed effects include skin and eye irritation, respiratory distress, gastrointestinal upset, tinnitus, metabolic acidosis, and potentially life-threatening salicylate toxicity with repeated or high-dose exposure.
4.3 Indication of any immediate medical attention and special treatment needed:	Treat symptomatically.
