2.3 Other hazards:	
Inhalation:	dust can irritate the respiratory tract, cause coughing, shortness of breath, and prolonged exposure may lead to lung damage.
Ingestion:	can cause nausea, vomiting, abdominal pain, and diarrhea, and may lead to more serious effects like liver or kidney damage with high doses.
Skin Contact:	Can cause mild irritation, redness, or itching upon prolonged or repeated exposure.
Eye contact:	Can cause irritation, redness, and watering; direct contact with dust may damage the eyes.
Chronic Exposure:	Prolonged or repeated exposure may lead to liver and kidney damage, respiratory issues, joint pain, and symptoms of molybdenum toxicity such as gout-like effects.
Aggravation of pre-existing conditions:	may worsen respiratory disorders (like asthma or bronchitis) and could exacerbate kidney or liver problems in individuals with pre-existing conditions.

4.1 Description of first aid measures	
General information:	
After inhalation:	If breathed in, move person into fresh air. If not breathing, give artificial respiration. Consult a physician.
