Inhalation:	can irritate the respiratory tract, cause coughing, shortness of breath, and in high concentrations, may lead to headache, dizziness, or central nervous system depression.
Ingestion:	can cause nausea, vomiting, abdominal pain, metabolic acidosis, kidney damage, central nervous system depression, and can be fatal if not treated promptly.
Skin Contact:	can cause irritation, redness, and in prolonged or repeated exposure, may lead to dermatitis or systemic absorption causing toxic effects.
Eye contact:	can cause irritation, redness, tearing, and discomfort, but it is generally not severely corrosive.
Chronic Exposure:	may lead to kidney and liver damage, nervous system effects, and prolonged skin or respiratory irritation, potentially causing long-term health issues with repeated contact or inhalation.
Aggravation of pre-existing conditions:	may aggravate pre-existing kidney, liver, or respiratory conditions, and can worsen skin disorders or neurological problems in susceptible individuals.
